#### **Course details**

The students will receive a Bachelor degree in Economics from AU and Master Degree in Economics or Business from Essex within 4 years (if the students complete within the expected study plan.) The student will study at AU for 3 years and ESSEX for 1 year.

#### Requirements

- 1. Accumulative GPA of 2.7
- 2. IELTS 6.5, with minimum score of 5.0.
- 3. The applicants must be enrolled in the BBA (Major in- Marketing, Finance, Accounting,Industrial Management & Logistics, International Business Management, Management-Leadership and Entrepreneurship, Economics) at Assumption University.

#### **Tuition Fees**

Approximately 750,000 Baht (Tuition fees for 1-year Master program at ESSEX) / Scholarships available up to GBP 2,000

Accommodating Fees per year: start from (4,000 Baht- 7500 baht)/per week (for 48 - 52 weeks contract). Living cost per year (inclusive of accommodation): range from 360,000- 555,000 Baht

#### **Application Period**

At least 4 months before the semester begins

\*Deposit of 10,000baht for the application fees (It's refundable only in the case of visa or University rejection.)

**Semester Begins: First week of October**
